PROJECT APPROACH

Minimum Work Tasks

To minimize proposed service hours, L&B recommends proper preparation, adequate staffing, and time efficient equipment for prompt service within allotted work time. L&B will delegate tasks based on strengths and maintain accountability and proper supervision to ensure tasks are completed properly, maximizing quality, speed and efficiency for maximum productivity.

L&B will meet minimum work tasks through the use of Tasks Checklists that indicate contractual daily, weekly, monthly, quarterly, semi-annual and annual task obligations. This will serve as a guide for L&B employees and keep them accountable. In addition, through internal Quality Control Inspection Reports and the Smart Inspect janitorial quality control application, supervisors will conduct routine inspections and maintain records for review, to ensure minimum work tasks are met and quality standards are maintained.

As required by the contract, janitorial cleaning will be performed after normal business activities/hours unless a day porter is required or servicing during normal business activities/hours is required as stated in the contract. Janitorial cleaning services scheduled during normal business activities/hours will not interfere with normal business operations. Services will complement work schedules to meet the operational needs of the County/facility. Any necessary modifications to work schedules will be made accordingly to ensure County, Building Manager, and facility satisfaction.
