

Scheduling

Accurate scheduling is a vital component of our effectiveness and client satisfaction. Our automated scheduling system provides
Broward County Government with the most accurate, efficient scheduling available. The system not only plans who is scheduled for work and when, it also integrates with our training compliance tracking to ensure scheduled security officers have the necessary training and skills.

Scheduling

In addition, managers who are directly responsible for employee schedules participate in our **How to Create and Manage a Schedule** training program. This training helps ensure schedules are efficient and meet contractual requirements.

Our quality scheduling protocols include:

- Providing all hours of contracted service.
- Scheduling officers who have received every training specific to your site.
- Maintaining scheduling standards such as a maximum of 12 hours per shift, minimum of 8 hours off between shifts, and at least 24 consecutive hours off each week. Fast Guard Service scheduling system records the requirements of each post and allows for effective tracking of all changes.

We can also quickly and appropriately respond to call-offs due to illness or other events that could potentially disrupt fulfillment of coverage requirements. Fast Guard Service employees are given more than a week's advance notice of their schedules so they can effectively manage their time and personal commitments without compromising their professional lives and service delivery.



Transition Philosophy

Every successful project phase-in requires early coordination and involvement by all supporting resources, very much like the process of putting a puzzle together with parts that never stop moving. Vero Beach Regional Airport is located in Indian River County, just over one mile from downtown Vero Beach.


The airport has three runways, with the longest runway measuring 7,314 feet. The airport serves all facets of general aviation, including intercontinental business jets and most air carrier aircraft.




California Paradise Fire 2018

We created the security plan for the evacuation shelter. Over 150 guards were deployed to provide security 24/7 for approximately one year.




Texas
