Broward County Animal Care Advisory Committee Minutes of November 9, 2018 meeting

A meeting of the Animal Care Advisory Committee was held on Friday, November 9, 2018 at the Broward County Animal Care shelter, 2400 SW 42nd Street, Fort Lauderdale, FL. Dr. David Eich, Chair, called the meeting to order at 11:24 am.

1. Roll Call
