**SB1084/HB805- Volunteer Ambulance Services (*PASSED*)**

- Authorize use of lights and sirens to volunteer ambulances
- Exempting volunteer first responder agencies from COPCN process and requirements

**SB766/HB397- Cardiovascular Emergency Protocols and Training (*DID NOT PASS*)**

- DOH provides medical directors of EMS with providers of adult cardiovascular services requiring the department to develop a sample heart attack triage assessment tool
- Medical Directors must implement certain protocols for heart attack patients
- Dispatchers receive telecommunicator cardiopulmonary resuscitation training

**SB348/HB461- Medicaid (*PASSED*)**

- Revising the types of emergency transportation vehicle services provided to Medicare-eligible persons for which Medicaid shall pay deductibles and coinsurance

COVID-related bills:

**SB74/HB7005** – Providing preliminary procedures for civil action based on COVID-19 claims. (*DID NOT PASS*)

**SB122/HB133** deals with the introduction of baby boxes under the safe haven law.  
**(BILL WITHDRAWN)**

*Authorizing the Department of Health to approve, and certain hospitals, emergency medical services stations, and fire stations to use, newborn infant safety devices to accept surrendered newborn infants under certain circumstances; requiring such hospitals, emergency medical services stations, or fire stations to physically check and test the devices at specified intervals; providing additional locations to which the prohibition on the initiation of criminal investigations based solely on the surrendering of a newborn infant applies, etc.*

Grant Committee – Alison Zerbe reported

- The new 2022 EMS Grants will probably be announced around July 2021.

Old Business

- Chapter 3½ changes passed by Commissioners; they were proposed by Consumer Protection. They included ADA compliant requirements for lifts and ramps for wheelchair vehicles. Also, structures must have adequate secure factors and use manufacturer's specifications.
- Mayor Geller has added to the proposal. It gives the private ambulance companies the ability to use drivers-only on their basic life support vehicles to assist with their staffing shortages. The ordinance stated before that you can have drivers-only but they were to be in school or finishing school within six months. They took this out but added that they are required to have a hack license; this was not required before. PASSED.

New Business – Alison Zerbe

Announced and thanked Dr. Craig Mallak, Medical Examiner, who was not present, will retire on June 12, 2021.

EMS Council's Nomination Committee has lost most members; therefore, A. Zerbe is reaching out to members who would be interested in serving. She hopes to have a meeting before the September 2nd EMS Council meeting.
