INTERESTED IN EARNING MORE CONTACT HOURS?

- 28 hours of training are required during the 2-year building certification cycle.
- 60 hours of training are required during the 4-year fire certification cycle.
- By attending Broward BORA's board meetings and/or committee meetings, 1 hour of the required credit will be earned.
- By attending professional association meetings approved by the BORA Staff (i.e. FGAMI, IAEI, COEA), ½ hour of the required credit will be earned for each meeting attended.

A maximum of 14 total contact hours through board and/or committee meetings can be earned per certification cycle.

2021 BUILDING SAFETY INSPECTION PROGRAM

In the upcoming months, municipal building departments throughout Broward County will notify property owners whose buildings are subject to the Building Safety Inspection Program, beginning the process of having the property inspection completed by a licensed professional engineer or a registered architect. Please be advised that the Building Safety Inspection Program does not require the building to be brought up to current code.

Building Safety Inspection Program – Handout

The following structures are included in the Building Safety Inspection Program:

- Buildings 3,500 square feet or more, built in 1981 (40 years ago).
- Buildings 3,500 square feet or more, built in 1971 (50 years ago).

The following structures are **exempt** from the Building Safety Inspection Program:

- U. S. Government Buildings
- State of Florida Buildings
- Buildings built on Indian Reservations
- School buildings under the jurisdiction of the Broward County School Board
- One and two-family dwellings
- Minor structures defined as buildings
- Structures in any occupancy group with gross floor area less than 3,500 square feet





If you do not receive a notification and your property is 40 years or older, please contact the building department in the municipality where your property is located. You will still be held accountable for completing the inspection whether the municipality contacts you or not.

BORA ACH ELECTRONIC PAYMENTS PROGRAM

The Board of Rules and Appeals is accepting ACH (Automated Clearing House) Payments. This payment solution is voluntary. We can only process one new ACH jurisdiction at a time. To enroll in the electronic funds transfer, just send an email to Maria "Pat" Kong (mkong@broward.org).

Be aware that payments processed through ACH are not immediate. The payments may take 2-4 days to process. Therefore, to take advantage of the 3% discount you must submit your payment ahead of time before the 15th of each month.

To report your online payment to BORA, you must send the following supporting documentation to mkong@broward.org every month:

- 1. Copy of the electronic transaction reporting the total amount made to our account.
- 2. Remittance Advice form with the information about the month reported, showing the deduction of the 3% discount if submitting the electronic payment before the 15th of each month.
- 3. Breakdown showing the minimum of \$2.00 charge if applicable.

The books will take about two weeks to order. Please follow the steps below:

- 1. Send your completed application, with your City or County Building Official's signature, by email to Brianna Curry (bcurry@broward.org) or Maria Kong (mkong@broward.org).
- 2. Books can be picked up at our office in Government Center West (1 North University Dr., Suite 3500B Plantation, FL 33324) between the hours of 8:00 AM to 4:15 PM, Monday through Friday.
- 3. The six-month loan period starts when the books are picked up from the Broward County Board of Rules and Appeals' office.
- 4. Individuals can return borrowed books by the end of the six-month loan period or utilize the onetime 3-month extension.
- 5. Remember, the books are loaned to other code officials after they are returned. Please show consideration by not writing/highlighting in the books and returning materials on time.

BUILDING DEPARTMENT VISIT ANNOUNCMENTS

At a recent Board Meeting, the following items were discussed for building departments throughout Broward County. As the Board of Rules and Appeals' Chief Code Compliance Officers visit the Building Departments please remember:

- Building departments can no longer require contracts unless the building official deems the pricing on the permit application is not correct.
- Applications no longer need to be signed by the owner.





ENERY CODE COMPLIANCE TRAINING

Broward BORA Chief Energy Code Compliance Officer, Timothy de Carion, provides training to staff members at municipal building departments about energy code compliance. The training will assist with increasing uniformity in the way that they energy code is enforced throughout Broward County. The training sessions can be held virtually or in-person.

VIRTUAL TRAINING UPDATES

At the March 11, 2021 Board Meeting, a building code amendment (FBC, Section 104.18) was adopted regarding virtual training. Starting, January 1, 2022, only half of the required 28 hours of training will be permitted to be obtained through virtual courses.

For the current 2020-2021 certification cycle, there is no limit on the hours of training acquired virtually due to COVID-19.



NON-INTERFERENCE WITH BUILDING OFFICIALS

Please see the *Interference with Certified Building and Fire Code Personnel* memorandum below. This was approved, by vote by the Board of Rules and Appeals on December 8, 2016.

Pursuant to Florida Statutes 468.604 and 633.118 and the Broward County Charter, the Building and Fire Departments are to be administered on a professional and non-political basis.

The Florida Building Code (Chapter I Broward County Amendments and Local Fire Amendments) addresses on principal code enforcing officer for each of the certified Building and/or Fire Departments; that being, the Building Officials (Section 104.1.1) and/or the Fire Code Officials (104.19.2).

The Board of Rules and Appeals certifies every building and fire department after it has determined to its satisfaction that the building and fire inspectors, (which include the Building Official, Chief Structural Inspector, Chief Electrical Inspector, Chief Plumbing Inspector, Chief Mechanical Inspector, Fire Code Official/Fire Marshal, Fire Plans Examiner and Fire Inspectors), are competent and qualified by the provisions of the Florida Building Code (Chapter I, Broward County Amendments and Local Fire Code Amendments) to act in their respective disciplines as may be amended from time to time by the Broward County Board of Rules and Appeals.

For the purpose of inspection and plans examination and other functions that require personnel certified by the Broward County Board of Rules and Appeals, competent and qualified building and fire inspectors and building and fire plans examiners along with inspectors shall be employed by the local building departments whose elected or appointed officials charged with the responsibility of ensuring compliance with the Florida Building Code (Chapter I, Broward County Amendments and the Local Fire Code Amendments). If any elected or appointed officials knowingly or negligently allow or permit any new building or structures, both private and public or any alterations, additions or repairs in any new or existing building or structure, both private and public, including but not limited to county buildings or structures, municipal building or structure, hospitals, and any other building or structure of any governmental authority, to be erected within Broward County in violation of the Florida Building Code, or Florida Fire Prevention Code, or if any of the elected or appointed officials prohibit, by any means, directly or indirectly, the use of any materials, types of construction and methods of design authorized by the code or alternate materials, types of construction and methods of design approved by the provisions of the codes, then the elected or appointed officials may be removed from office for nonfeasance, misfeasance or malfeasance in office.

Per state law, violation of the preceding paragraphs by an elected or appointed official or officials shall constitute a misdemeanor of the second degree punishable in Florida Statutes section 775.082 or 775.038.



Broward County Code of Ordinances, ARTICLE IX. - BUILDING AND CONSTRUCTION, Section 9.02

"Building Code and the Board of Rules and Appeals" mandates that BORA members shall be appointed as follows:

- Seven (7) members and six (6) alternates shall be appointed by the Broward County League of Cities.
- Six (6) members and three (3) alternates shall be appointed by the County Commission.
