BROWARD BORA RATE DECREASE PASSED BY COUNTY COMMISSION

PLANTATION, Fla. - On May 10, the Broward County Board of Rules and Appeals proposed a rate decrease of the municipality construction fees as well as the elimination of the current \$50 application fee for building and fire code appeals.

The Broward County Board of Rules and Appeals staff proposed to reduce the municipal fee charged to all government jurisdictions in Broward County from the present \$0.68 per \$1,000 of construction valuation to \$0.65 per \$1,000. This change will result in a 4.4% rate decrease. The current fee has been in place since October 2012.

The final decision was made by the Broward County Commission on August 14, 2018. The new policies will be in effect starting October 1, 2018.

Our office has notified all Broward County building departments to give an adequate amount of time for municipalities to update their systems.

SUBSTANTIAL FUNDING FOR FY 2018 EDUCATIONAL SEMINARS

In FY 2018, the Broward County Board of Rules and Appeals invested in excess of \$171,614.00 in Certified and Non-Certified courses for over 275 students at no cost to building and fire departments throughout Broward County.

The Board of Rules and Appeals made the recommendation for funds to be taken from reserves and the Broward County Commission approved the recommendation with a unanimous vote.

BORA GETS INVOLVED IN THE FIRE COMMUNITY

PLANTATION, Fla. - The Broward County Board of Rules and Appeals staff is involved in education, code development and seeking a uniform application of the fire codes by being a participating member of several fire related committees.

Members of the Broward BORA staff attend monthly meetings, provide guidance, update (as it relates to the fire codes at the Broward Fire Chief, Fire Prevention Sub-committee) and participate in joint Fire Marshal meetings between Miami-Dade and Broward counties to achieve a uniform approach between counties as it relates to the application of the Florida Fire Prevention Code and on new fire code issues.

40 YEAR (AND OLDER) BUILDING SAFETY INSPECTION PROGRAM

The 40 Year (and Older) Building Safety Inspection Program has been in effect throughout Broward County since January 2006. This program is modeled after a system that has been in existence in Miami-Dade County since the mid-1970s. This program requires structural and electrical safety inspections for buildings 40 years old (or older) and every ten years thereafter. By having such a program in effect, the possibilities of future building failure are minimized and structures will be better prepared for hurricane force winds. **Notifications were sent to all Broward County municipality building departments in June 2018.**

WHAT IS THE TIMELINE?

JUNE

The Board of Rules and Appeals obtains building data from the Broward County Property Appraiser's Office and forwards it to each municipality in Broward County.

JUNE -AUGUST

Building Officials notify property owners whose buildings are subject to the 40 Year (and Older) Bulding Safety Inspection Program for the specified calendar year.

SEPTEMBER-NOVEMBER

90 day period when property owners return the Florida design professional's report to the city's building department where the building is located

DECEMBER-MAY

180 day period property owners have to complete the necessary electrical and structural repairs.

Broward BORA Provides HVHZ Exam Sponsorship

To improve and facilitate the Building Code professionals recruiting process, we sponsor the **High Velocity Hurricane Zone Exam** (HVHZ) for qualified individuals applying for the positions of Building Officials, Structural Inspectors, Chief Structural Inspectors and/or Structural Plans Examiners on the first attempt. Professionals who have not worked in either, Miami Dade or Broward counties can meet the required HVHZ experience by passing the HVHZ exam. To have the first HVHZ exam paid for, a Building Official representing the jurisdiction should submit a request to the Broward County Board of Rules and Appeals office.
