2022 BUILDING SAFETY INSPECTION PROGRAM FOLLOW-UP

Property owners of buildings 40-years old or older, should have been notified by the municipal building departments where the property is located to begin the **Building Safety Inspection Program** process.

If the notification was not received, please contact the building department in the municipality where your property is located. Property owners will be held accountable for completed the inspection whether the municipality contacts you or not. Please be advised that the inspection does not require the building to be brought up to current code, but the code in effect at the date listed on the certificate of occupancy.

NEW BROWARD BORA FORMAL INTERPRETATIONS

Formal Interpretation #31 – Exempting solar panels from rooftop clearance requirements, Sections 1522.3, 1522.3.1

The rooftop clearance requirements for permanently mounted equipment as specified in FBC Section 1522.3, 1522.3.1 are not intended to be applied to rooftop mounted photovoltaic panels and solar thermal installations.

Formal Interpretation #32 – Paper Reduction, providing that Roof System Application Notice of Acceptance submittal only include the product approval documentation that matches the installation criteria, Section 1512.2.1

The intent of FBC 1512.2.1 is that when a proposed permitted roofing system utilizes a current and valid product approval, these product approvals may contain multiple pages describing a multitude of various roof systems. The Board has determined that it is not necessary to submit the entire product approval package with the roofing application submittal.

In an effort to reduce paperwork, it has been deemed only the necessary pages are required for permit submittal. Please select the system that matches your installation criteria and include only those pages that apply. (i.e., Cover Pages, Product Data Sheets, Specific Installation Pages, General Limitations, etc.)

Formal Interpretation #33 – Proposed Formal Interpretation pertaining to the maximum distance from the source of hot water to the fixture in commercial buildings per Section 607.2 of the FBC Plumbing Code and C404.5 of the FBC Energy Conservation Code. Section C404.5 shall be applicable per Chapter 1, Section 102.1 because when there is a conflict between a general requirement and a specific requirement, the specific requirement shall apply.



UPDATED BORA CERTIFICATION APPLICATIONS FOR BUILDING OFFICIALS AND CHIEF INSPECTORS

The applications include fields for applicants to disclose all the jurisdictions where they serve and the titles that they hold in each jurisdiction.

BROWARD BORA COMPLIMENTARY BOOK LOAN PROGRAM

The Broward County Board of Rules and Appeals' Complimentary Book Loan Program is available to municipal code officials. There are books available for studying for the following state license exams:

The books will take about two weeks to order. Please follow the steps below:

- Plumbing Plans Examiner
- Building Code Administrator

- Send your completed <u>application</u>, with your department's Building Official's signature, by email to <u>Brianna Curry</u>.
- The six-month loan period starts when the books are picked up from the Broward County Board of Rules and Appeals' office.
- Individuals can return borrowed books by the end of the six-month loan period or utilize the onetime 3-month extension.

AMENDMENTS TO SECTION 104.1.1 AND SECTION 104.3 OF FBC (2020) POSTPONED

The Board of Rules and Appeals approved the postponement of proposed amendments to Section 104.1.1 and Section 104.3 at the **November Board Meeting**. An ad hoc committee will be created in 2023 to ensure that valuable insight and recommendations are provided to the Board.

BOARD APPROVAL: BROWARD COUNTY AMENDMENTS TO THE FLORIDA BUILDING CODE, 7TH EDITION (2020)

Section 110.15, Building Safety Inspection Program, and readoption of Board of Rules and Appeals Policy #05-05, Building Safety Inspection Program, to include amendments and inspection forms.

Section 105.3.1.5, Subsection 4, adding an exception related to a "Simplified Permitting Process for Fire Alarm System Projects" to provide consistency with Senate Bill (SB) 1140-2022.

Section 105.17, Streamlined Low-Voltage Alarm System Installation Permitting, revising the definition of the term, "low-voltage alarm system project" to provide consistency with Senate Bill (SB) 1140-2022.


Section 105.3.1.6, Reviewing Application for Building Permits, to provide consistency with House Bill (HB) 423-2022 that modified Florida Statute 553.792; revising requirements for when a local government requests certain additional information from an applicant for a building permit; limiting the number of times the local government may request such information; providing requirements for a local government if a certain request is made by an applicant.

Section 105.3.1.5, Chapter 1, Florida Building Code, 7th Edition, (2020) related to the design and installation of fire protection systems to provide consistency with Senate Bill (SB) 286-2021.

Section 105.18, Demolition, to provide consistency with HB 423 of 2022 that created subsection (25)(a) of Florida Statute 553.79 providing that a local government may not prohibit or restrict demolition permits for single-family residential structures located in flood hazard areas.

Section 111.1.1, Use and Occupancy, to provide consistency with HB 423 of 2022 that amended Florida Statute 553.791(13), requiring the local building official to issue a certificate of occupancy or certificate of completion within a certain number of days after receipt of certain information, including the payment of all outstanding fees; providing that a certificate of occupancy or certificate of completion is automatically granted and issued, and the permit application closed, under certain circumstances; requiring the local building official to provide a written certificate of occupancy or certificate of completion within a specified time.

2023 BROWARD COUNTY FIRE INSPECTOR EXAM REGISTRATION

The 2023 exam dates are available for the Broward County Fire Inspector Exam:

- Friday, January 6, 2023
- Friday, March 10, 2023
- Friday, May 12, 2023 (Mandatory F-103.5.3.2)
- Friday, September 15, 2023
- Friday, November 17, 2023 (Mandatory F-103.5.3.2)

To qualify for the exam, submit the completed and signed application and policy statement by mail to the Broward County Board of Rules and Appeals (1 N. University Drive, Suite 3500B, Plantation, FL 33324) or by email to Jonda Joseph.

The Broward County Board of Rules and Appeals will pay for first-time test takers to take the Broward County Fire Inspector Exam. The retakes must be paid for by the test taker. A \$60.00 fee must be paid by money order before the exam **OR** by debit card/credit card on the day of the exam.

Also, the Broward BORA will, upon request, provide auxiliary aids and services leading to effective communication for people with disabilities, including qualified sign language interpreters, assistive listening devices, documents in Braille, and other ways of making communications accessible to people who have speech, hearing, or vision impairments.

Broward County Code of Ordinances, ARTICLE IX. - BUILDING AND CONSTRUCTION, Section 9.02
