

We are very proud of our investments in small businesses and economic development in Broward County! The County Commission has a clear vision that encourages and supports creating opportunities for our residents, businesses, and the community at large.

We have many accomplishments to celebrate. Broward County's Construction Apprenticeship Program became effective in April 2021, requiring the use of apprentices in eligible County construction projects. We opened the Alan B. Levan I NSU Broward Center of Innovation (Levan Center), a public-private partnership with the County and Nova Southeastern University. The goal is to develop, nurture, and attract talent and innovation that will propel the region into the foremost hub of the country's global tech and innovation ecosystem.

It was my honor, as Broward County Mayor, to celebrate the graduation of the 7th Kauffman New Venture Class Cohort of Broward Entrepreneurs at the Levan Center recognizing the work completed during this 10-week program. In November 2021, we hosted the annual Florida International Trade & Cultural Expo (FITCE) where more than 1,000 professionals and 60 countries throughout the global trade ecosystem connected to strengthen relationships with global stakeholders, engage local and international dignitaries, collaborate, and learn about importing and exporting opportunities around the world.

There are several contracting opportunities on the horizon. If you are not certified as a County Business Enterprise (CBE) / Small Business Enterprise (SBE), now is the time to Get Certified and get your **Piece of the PIE!** The Office of Economic and Small Business Development (OESBD) also administers the Federal Certification Program. Consider getting certified as a Disadvantaged Business Enterprise (DBE) or Airport Concessions Disadvantaged Business Enterprise (ACDBE) to participate in projects funded by the US Department of Transportation.

There is no question that Broward is on the Move!

Thank You. Thank you to our valued business and economic community, thank you to our OESBD team, and thank you to our County Commissioners. Every success we achieved in 2021 is just a reflection of the trust hundreds of businesses, our Commissioners, and our team has in us. Their trust led to real opportunities for a community that helps keep the wheels of our economy turning. In Fiscal Year 2021:

- Broward County committed over \$245 Million to small businesses on County projects.
- We exceeded our County Business Enterprise (CBE) requirement of at least 25 percent, achieving an average of 55 percent CBE participation on County contracts.
- We partnered with the Greater Fort Lauderdale Alliance and municipalities to attract \$239 Million in new capital investments to our community.
- OESBD held more than 120 targeted virtual workshops with industry experts to connect businesses with resources and small business opportunities.
- County projects were escalated to help keep the wheels of our economy moving.

As of December 2021, more than \$61 Million has been paid to CBE subcontractors working on the Broward County Convention Center Expansion.

2021 remained a challenging year for our business community and the County as we spent the last two years learning to adapt. I am honored to have served as Broward County Administrator for the past 14 years, and I am proud of the resilience of our business community, the dedication of our employees, and the commitment of the County Commission and community partners.

Our purpose remains steady. Broward County is committed to creating a better life every day for everyone. I wish each of you continued success and thank you for your unwavering support during my tenure as County Administrator.

Our mission and purpose, underscored by our values, remains steadfast. We continue to execute our shared value approach where our business decisions reflect the goals of the County Commission and align with fostering opportunities and prosperity for all. **The County continues to provide real opportunities to certified Broward County small businesses**:

- The Mobility Advancement Program (MAP Broward) continues to provide economic development benefits for eligible certified small businesses. As of December 2021, OESBD assigned CBE goals to 99 of 148 surtax-funded projects reviewed for goal assignment. 58 CBEs have been awarded surtax projects (County and Municipal projects combined) averaging a 32% CBE participation goal. When all of these projects are under construction, our small business community will be well represented. It should also be noted that several CBEs are also participating in transportation-surtax projects as Prime contractors. This opportunity will continue to grow and prepare our small businesses to be seen as far more than subcontractors.
- As of December 2021, 49 CBE firms secured contracts on the Broward County Convention Center Expansion. 32% of the total dollars paid have gone to CBEs. Thanks to our CBEs, Phase 1 of the project was completed on time for the Fort Lauderdale International Boat Show to use.
- Through our Kauffman Foundation FastTrac® Entrepreneurship Development Program, we helped 16 entrepreneurs in 2021 to refine their business concept, identify the components of a strong business plan, and access the appropriate resources for launch. Three businesses competed in the Pitch Competition and received seed money; the winner, Marva Williams, will launch her product in 2022.

The Broward Film Commission is now a part of OESBD. As a result, we will look at ways to create even more opportunities for small businesses.

I am thankful for our business and economic community, which is at the center of everything we do in OESBD. I am especially grateful for our 29 talented team members, who work hard every day to ensure we realize our vision. I am honored to lead them. As always, stay engaged with us, become a vendor, and get certified! Real opportunities are here! I encourage you to keep reading and learn more about our work.





OESBD Recognized for Excellence

National Association of Counties (NACo) Award

Award of Excellence for The Broward County Way (A Reference Guide to International Protocol for Broward County)

City-County Communications & Marketing Association (3CMA)

Awards for Excellence in the Marketing and Tools category for Best Use of a Promotional Item and Government Service for innovative programs that meet residents' needs.

To secure the win under the category Best Use of a Promotional Item, OESBD partnered with FPL at the height of the COVID-19 pandemic to create a "Powering Up your Business" package filled with face masks, a power-charging bank, window stickers, notepad, pen and a relaxation eye mask for local certified businesses to show them what they mean to the local economy. The packages also included a folder with resources and information to help them keep their businesses running.

The second award was snagged for a creative e-mail campaign to help increase the Census 2020 response rate with a focus on hard-to-reach communities. With response rates impacted by COVID-19, OESBD asked business owners and employers to "Show Your Love for Broward" and allow their employees 15 minutes of paid time to complete their census at work.



OESBD Investing in Residents and Businesses

Construction Apprenticeship Program

The Construction Apprenticeship Program was unanimously approved by the County Commission and became effective on April 5, 2021. The Program helps to promote opportunities for training and experience that will assist in ensuring that a trained workforce is available for future County construction projects. It's the intent of the County to increase the number of apprentices hired by contractors in Broward to develop a more skilled labor pool for County construction projects. OESBD continues to work with the Florida Department of Education (FLDOE) to increase awareness of Get There Florida, a workforce education initiative, which highlights 17 career pathways offered at Florida's 28 state colleges and 48 technical colleges.

OESBD Working with Partners

Airport Concession Disadvantaged Business Enterprise Program

The Office of Economic and Small Business Development formulated and submitted to the Federal Aviation Administration (FAA) Broward County's Airport Concession Disadvantaged Business Enterprise (ACDBE) goal methodologies for car rental and non-car rental concessions at the Fort Lauderdale-Hollywood International Airport (FLL). These goals were based on information provided by Broward County's Aviation Department regarding existing concession agreements at FLL.

- ODollars received by ACDBEs under 6 car rental concession agreements at FLL \$5,067,303
- Obliars received by ACDBEs under 12 non-car rental concession agreements at FLL \$39,285,011 (I.e. food and beverage, news and gifts, self-service baggage carts, advertising, and management agreements)

Currently approved ACDBE program goals for FY 2021-2023 are as follows:

- Non-Car Rental Concessions 23.3%
- Overall ACDBE participation under Car Rental Concession Agreements in FY 2021: 2.73%
- Overall ACDBE participation under Non-Car Rental Concession Agreements in FY 2021: 24.02%

The Greater Fort Lauderdale Alliance

The Alliance is Broward County's private-sector economic development partner. They work with the County and its 31 municipalities to focus on creating, attracting, expanding and retaining high-wage jobs and capital investment in high value targeted industries, developing more vibrant communities, and improving the quality of life for our area's citizens. In Fiscal Year 2021, the efforts of this partnership resulted in:

Broward Municipal Services District

The NW 27th Avenue Inspector Trainee Pilot Program was launched. The program affords residents, living in the BMSD and similiar areas to obtain the Florida Department of Transportation (FDOT) Construction Training Qualification Program certifications in three different disciplines while working part-time on a County construction project.

The Economic Development Toolbox continues to stimulate business growth in the BMSD. To date, the program has Commission approval for projects, seven of which are in the construction phase, one demolition project, and another in the design phase. Changes to the code specifically relating to grant projects have accelerated the grant approval process and enabled OESBD to bring new projects to the table much faster. New applications are being accepted.

In December, the County Commission approved their participation and funding for the Southern Opportunity and Resilience (SOAR) Loan Fund. The County's funding will provide flexible, affordable capital up to \$100,000 and free business support services to small businesses and nonprofits in Broward County to help them navigate and rebuild from the Covid-19 economic crisis.

Broward County participates in and promotes the County's Direct Cash/Job Creation Incentive Program, High Impact Performance Incentive Capital Investment Tax Credit and Urban Jobs Tax Credit Programs. Activity under the programs included:

Workforce Development

Broward County continues to work with its economic and workforce development partners to deliver the quality workforce and employment opportunities needed to fuel our economy.

\$843,000 generated through Broward County's partnerships with the Greater Fort Lauderdale Alliance and CareerSource Broward in workforce development partnerships with the private sector.

610 projects were reviewed by OESBD for Workforce Investment Program applicability (FY 2018-2021).


