**Welcome & Introductions:** Tom Campbell, Chair, called meeting to order and attendees introduced themselves.

**New Business:**

**a. Furniture at Pier .....Dan Lindblade**

**Pier 66** has furniture to donate. Rebecca will contact providers and be the point of contact for Dan.

**b. Landlord Data Base.....Discussion**

Discussion centered around the need for a system Landlord Data base. Dan discussed the Multiple Listing Service (MLS) and exploring an organization to section off a component for the CoC. This would be a benefit to all housing providers as it would provide data on available units and amenities to help match individuals with units.

Discussion was brought up that each provider has their own list and historically, it has been a challenge to get them to share information. Initially this would not be the request of the providers, but rather to help recruit new landlords to participate in the CoC housing programs.

Steve Hudson brought up an excellent point of the need to input correct data as the system is only as good as the data that is put into it.

Dan and Rebecca will set up a meeting with an organization to approach them about the partnering to use an existing MLS. The objective is to have a potential partner by the next Housing Action Committee on May 9, 2019.

Keith C. brought up the social serve.com as a resource as well.

**c. Partners to Add to the Committee.....Discussion**

There was discussion regarding other partners to add to this committee.

- Collier Commercial Real Estate, **someone needs to be assigned**;
- Pompano Housing Authority, Rebecca to reach out;
- Mission United; Rebecca to reach out;
- Dania Housing Authority, Lisa V to follow up.

**d.** Dan discussed initiating a **Development component to this committee.**  
**This is a longer-term vision once the group is established, however while we are recruiting members, we should also target developers.**

**e. Landlord Appreciation/Recruitment Event** -- the group discussed having an event to acknowledge landlords who have worked with the CoC. There might be several possible “awards”. This would be an upscale event, perhaps a breakfast. Tom suggested July as the target timeframe. Amy C. offered the venue at Holly Cross as a possible location. A committee was put together that include:

**f.** Keith C. volunteered to help initiative a document that would serve as the basic standards for both landlords and tenants. Lisa V. mentioned triangulation document that outlines the tenants, landlords, and the housing providers role and responsibilities. Keith is going to collect current documents and work with Kenisha A. (HIP Intern) to craft a document for review.

**g.** Dan noted that this subcommittee should be focused, accountable, develop talking points and have access to funds. These items will be added to the next agenda.
