**Call to Order**: Senator Nan Rich called the meeting to order at 10:10 a.m. She

informed the attendees the mayor of Wilton Manors Justin Flippen passed away due to a heart attack. She stated the wonderful development in Wilton Manors would never have happened

without him. She asked for a moment of silence.

Roll Call: Completed by HIP Administrator, Rebecca McGuire, Ph.D. and guorum was

confirmed.

**Approval of Minutes**: Senator Rich asked for an approval of minutes.

**Result:** The minutes were approved.

Commissioner Rich had a few legislative and policy items. There was a proposed legislation in Tallahassee regarding homelessness issues and the Continuum of Care. This item was placed on hold. It corresponds state laws with federal statutes to eliminate

some outdated provisions. It increases the amount of the Challenge grant funds. Each CoC lead agency may receive annually from \$500,000 to \$750,000. The additionally funding was not approved.

The Senior Services Council Bill creating an independent taxing district for seniors did not pass this year. There are 420,000 seniors in Broward County and the fastest growing population is 85 and older.

Senator Rich wanted to reiterate the push is on for the census to be online making it difficult for seniors. Case managers and social workers are being trained to assist seniors complete the form online.

Another difficult to enumerate populations is children. Every single person in the household needs to be counted. Ten years ago, the County got an under count on children and lost Head Start money.

The business community has been helpful increasing funding for marketing which will be for adds for radio stations. The U.S. census ads started last Monday. They're going into ABC, NBC, CBS, CNN and that kind of marketplace.

Sandra mentioned they had their Nonprofit Executive Alliance CEO meeting. More than one member indicated while doing outreach they are finding a trend that people are associating voting with census. It is important to articulate the difference.

Senator Rich welcomed Keith Cavanaugh as the newest CoC Board member. Mr. Cavanaugh is the Broward program supervisor at Broward Outreach Center, Miami Rescue Mission. He has worked in many different roles.

Updates on open CoC seats was provided. Lee Ghezzi from the North Hospital District has put forth someone to replace him. There was a candidate a portable housing developer who has been out of town. Broward Workshop had a candidate who lives outside Broward County. During the Sunset Review, it has been recommended that the Broward Residency requirement be lifted.

Robert Hernandez was introduced as the Deputy City Manager for the City of Fort Lauderdale.

#### **COMMUNITY REPORTS:**

**United Way Broward County Business Council on Homelessness** 

Lynne Wines was not present.

Maria Hernandez reported in December they finally secured a contract and a leasing grant from the City of Fort Lauderdale. The contract they have been executed with Showering Love, and housing programs.

#### **Homeless Providers Stakeholders Council**

Joann Anstett, Co- Chair of the Council, stated January was an engaging meeting where there was a brainstorming session to identify gaps and needs in the community.

In February, Erin Weiss did a presentation on HIV and aging populations and how services are critically needed, and Ricardo Moore, HMIS Manager, did an HMIS presentation on the new systems and updates.

# Performance, Outcomes, Needs, and Gaps (PONG)

Sandra Einhorn encouraged members to attend the PONG meetings. They go over some critical items. They approved the NOFA Policy and Procedures during the last meeting.

They were presented with an updated project scoring template for new and existing projects, which was deferred to the next meeting. They wanted more of an opportunity to look at some of those scoring items specifically related to bonus points. They wanted to make sure the scoring was clear and concise and fair to everybody. There was a discussion around what that should look like and how to prioritize bonus points and some existing outcomes.

The date and time of the PONG meetings has been changed to the fourth Friday of every month at 10:00 a.m. in A337.

# **Consumer Advocacy**

Danny Osley reported last month they were in the process of looking at by-laws. For the last two or three years they have been recruiting individuals that were homeless and they are moving to expand the recruitment to advocates.

#### **Youth and Families Assessment**

Carole Mitchell, Broward County School Board was not present.

### **Housing Action Committee**

Tom Campbell reported they did not meet in February.

Tom reported last year Broward Partnership was awarded a \$25 million low income housing tax credit through the Housing Finance Corporation to build a 72-unit affordable housing project on the parking lot of the Central Homeless Assistance Center. They are in the design phase. Permits should be submitted within the next couple months. Shovels should go into the ground September or October of 2020.

Senator Rich reported Fran Esposito and her team went out to the homeowners in the area, brought them together and had multiple meetings. They learned working together can remove negative feelings.

Reallocation of Funding 1<sup>st</sup> Quarter

There are routine utilization meetings with lengthy discussions. The providers have made a significant effort making great improvements. The County is reallocating funds as it relates to service categories. The only service category where money was reallocated the first quarter was Rapid Rehousing. The amount reallocated was \$135,000 and was divided between two other Rapid Rehousing providers.

The HIP Staff are working through cleaning up the coordinated entry process. The goal is to make this a smooth process that holds providers accountable for processing referrals in a timely manner.

The transition at the North Homeless Assistance Center continues to go well. There is still a lot to be done. Work on bathroom facilities is being prioritized. Due to age of the building a complete renovation of the bathrooms is being planned. A vendor removed the invasive trees from the East side of the property. The property to the South of the facility will begin shortly.

There was a comparison from last year to this year's submission. The data quality framework gives a snapshot of the data and the information being put into the system including errors. Time was spent walking agencies through reports that are generated showing how errors can be handled.

# **Update on the Main Library Encampment**

Dr. McGuire provided an update on the 80 individuals removed from the encampment. Originally 37 households were placed in Rapid Rehousing. That number is down to 20. Most have been moved to Permanent Supportive Housing. The goal is by September of 2020 the remainder will be self-sufficient.

#### **PUBLIC COMMENT**

Senator Rich announced the Point in Time Count (PIT) information will be available next month.

Dr. Greer expressed desire to partner with organization who are providing meals. Dr. Greer expressed his gratitude to the Children's Services Council who is helping address needs of homeless children by providing funding for services at the Day Respite. The

United Way provided half the funds needed and Children's Services Council provided the other half.

Anthony Ginsberg announced they are providing early voting transportation for the homeless.

Steve Werthman brought up concerns about the Coronavirus potential epidemic. Senator Rich stated the County administrators are working with the Department of Health.

Calls are being received from Palm Beach. They are in crisis mode for an encampment and are looking at Broward County's model for addressing the downtown encampment. Dr. McGuire will reach out.

A church in Fort Lauderdale has an initiative known as Laundry Love. Once a month a group of volunteers assist and provide vouchers to individuals experiencing homelessness to launder their clothes. In the past five months they have washed eight tons of laundry. For future events we are working on getting outreach workers there to connect.

A question was posed regarding panhandlers. An attempt is being made to deploy signage around the City of Fort Lauderdale discouraging panhandling. There is a lawsuit claiming it is free speech.

Senator Rich brought up the Lazarus Project in Miami Dade County. Jackson Memorial is engaged with the CoC on the project. Funding for Broward County is being sought.

Yvette Lopez announced, the they are updated their five-year consolidated plan. A questionnaire will be sent municipalities and stockholders.
