#### Dr. Keisha Grey/ Collective Impact/ Turn the Curve Report

Mission: Pulling all resources and make a lot with a little!

Dr. Grey brought the draft 'Turn the Curve" report in to review with the committee.

All sections of the turn the curve report was reviewed by committee. The committee discussed what needed to be removed from the report and what should be added to the report.

#### Best Ideas for what will work from the Turn the Curve Report

- Parent engagement
- Sharing resources with youth and families electronically and hard copy.
- Collaboration between school board staff and community organization.
- Educating youth and families on available mental health services/ counseling
- Providing youth with job readiness training,
- Identifying host homes for youth living in transition.
- Providing youth and families with access to employment and financial literacy (courses and information) to resulting in self-sufficiency.
- Providing youth and families with affordable health care, behavioral and mental Health/services.
- Providing families access to Homeownership education courses.

#### **Action Steps**

- Identify what works in other counties (e.g. Miami-Dade and Palm Beach County) in comparison to Broward County.
- Assessment for our homeless continuum of care.
