Homeless Continuum of Care (CoC) Updates:

The County, Broward Business Council on Homelessness and various CoC providers, are working with local businesses to assess and raise awareness on crimes related with the homeless population along 17Th Street Causeway.

The County is also working with local hospitals including Holy cross, Broward Medical, and North Broward to collaborate & ensure proper discharge planning is being conducted so individuals experiencing homelessness are not released back to the streets.

Broward County Schools District Homeless Education Liaison (HEART)

3,660 students experiencing homelessness (PreK-12).

3,382 students registered for the HEART program.

236 active high school seniors

184 unaccompanied homeless youth students.

As you know, our numbers continue to increase throughout the school year due to the identification strategies we have in place. Therefore, our total number identified to date has increased.
