

BHS® has successfully managed several CoC and other federal grant funds since 2008. The BII Program provides permanent and supportive housing for 51+ homeless disabled residents (including their families) diagnosed with a Severe and Persistent Mental Illness (SPMI). This program operates in scattered-site housing with multi-family apartments throughout Broward County. The CoC Program support is necessary because it allows clients to improve housing stability and self-sufficiency to the most vulnerable population in our community.

The target population are residents of Broward County's Continuum of Care (CoC) local catchment area that exhibit one or more of the following presenting challenges or special conditions:

- Lack of permanent, safe, and affordable housing,
- •Zero, low or very low income based upon HUD requirements
- •In need of long-term supportive services to due to their mental illness
- Ability to be self-sufficient and live independently

All clients are linked with case management supportive services to ensure that the resident remains on the road to recovery, stabilization and reintegration. Case management performs an initial intake and clients who have not had a psychiatric evaluation within the past 6 months will receive an updated mental health assessment from a partnering licensed mental health provider, licensed psychiatrist, or ARNP in order to provide an accurate and updated status on client's psychiatric condition. Annually, all clients receive an assessment to determine any newly developed needs, evaluate and establish new life plan goals, and to assure that they are stable and still functioning independently.

The Chronically Homeless population will be given priority as we coordinate with the CoC on vacancies for permanent housing. All households served will be referred through the Broward County HIP Coordinated Entry Team.

BHS® successfully met all targets for performance outcome measurements during the recently completed grant year. All 56 primary clients served maintained permanent housing. 97.8% of the adult client population maintained or increased their total income.

Performance targets will include 80% of clients maintaining permanent housing, either subsidized or unsubsidized, and 60% of adult clients maintaining or increasing income. Additionally 65% of primary clients who exit the program to permanent housing (subsidized or unsubsidized), will not return to homelessness within 6 months.

Project goals are established to enhance the participants' ability to retain and maintain permanent housing and self-sufficiency.

The sub recipient has extensive experience managing CoC grants.
