The Samaritan 2008 project provides a scattered site housing method for up to 30+ Chronically Homeless and unaccompanied, mental health consumers, specifically those diagnosed with a severe and persistent mental illness (SPMI). These clients are referred to Broward Housing Solutions® by the Broward County HIP Coordinated Entry Team. The Samaritan 2008 project follows The Housing First evidenced-based model.

Broward Housing Solutions® partners with community mental health agencies including Archways, Henderson Behavioral Health, BCEVS, Broward House, Regional Management Care, Pickett Fences, and Chrysalis to provide wrap around supportive services. Community mental health providers continue offering case management or wrap-around services to ensure that resident consumers remain on the road to recovery, stabilization, and reintegration. This is successfully accomplished while linking clients to mainstream benefits such as food stamps, applying for social security benefits, employment opportunities, etc. The target population includes no income, low income, or very low income chronically homeless persons who have been diagnosed with a severe and persistent mental illness (SPMI) and exhibit one or more of the following presenting problems/ or special conditions:

- Lack of permanent, safe, and affordable housing,
- Zero, low or very low income based upon HUD requirements
- In need of long-term supportive services to due to their mental illness
- Ability to be self-sufficient and live independently
- Have an emergency or sudden change in life situation such as job termination or death of caretaker requiring short term financial aid
- In need of long-term or permanent housing support due to their illness

During the first three quarters of the current award year, BHS® has successfully achieved a cumulative 98.8% outcome measurement for primary clients remaining in permanent housing. BHS® has also achieved a 100% outcome measurement for primary clients maintaining or increasing their total income.

Our target goals will be as follows: 1) 80% of our clients will remain in or exit to permanent housing. 2) 60% of our clients will maintain or increase their income. 3) 65% of participants who exit the program to permanent housing (subsidized or unsubsidized) will not return to homelessness within 6 months. Project goals are established to enhance the participants’ ability to retain and maintain permanent housing and self-sufficiency.
