Beginning in 2021, based on the Oversight Board's request, MAP Admin staff developed a Public Perception Survey

 Survey questions were based on input from Oversight Board, Appointing Authority, stakeholder agencies, County leadership, and recognized subject matter experts

Laying the Groundwork

 Survey was disseminated by MAP Broward stakeholders, via social media, through email distribution lists, and was hosted on e-kiosks at community events across Broward for approximately 6 months

Staff were introduced to grassroots community groups to discuss ways to inspire resident engagement

- Conducted a series of virtual meetings
- Met with East Oakland Collective to receive input on structure of future Focus Groups based on results of the survey

Staff reviewed and summarized the findings of the survey responses in July 2022


- Top 3 "priorities" identified by 625 respondents were:
 - 1. Reducing congestion
 - 2. Improving safety for all modes of mobility
 - 3. Improving convenience of public transportation

Laying the Groundwork (cont.) .

- Other high-value "themes" identified were:
 - Repairing and maintaining existing roads and bridges
 - Having more bike and ped infrastructure
 - Reducing mobility costs
 - Enhancing resiliency of transportation facilities

MAP Broward worked through the County's Learning & Organizational Development contract with FAU's Institute of Government to access experienced, community-based Focus Group facilitators.





MAP Admin researched the best practices nationally and within the County agencies that conduct focus groups to identify the best method of assuring attendance and quality participants. Compensation in the form of a \$75 gift card was identified and was part of the scope with this engagement.

Engagement Approach and Methodology

Focus Group Composition:

- Each focus group invited 12-15 participants from the pool of respondents
- Four(4) two-hour focus groups were conducted averaging 7-12 people in attendance.
- CMA Facilitators mirrored the population of the focus groups.
 The team's composition encompassed representatives from the following ethnic groups...
 - African American (English speaking Diaspora)
 - Hispanic American/Immigrant(Spanish and Portuguese)
 - Haitian American/Immigrant (Creole and French)

A key strategy for the above composition was to ensure that the attendees were comfortable in speaking with the CMA Facilitators and that there was an empathy in the cultural history, and current situations shared.

Regional Focus Groups

Scheduling for the sessions was based on feedback from the participants' preferences.

Focus Group Discussion were shaped by the pre-set questions and based on the four (4) common themes. The source being, approximately 700+ responses generated by the agency's Public Perception Survey. All sessions were recorded, and a transcript generated for the agency's files. All participants signed releases for the session attended.

A sampling of the questions posed to all attendees during the sessions included...

Satisfying Our Curiosity...


- "Why did you decide to participate in the Focus Groups regarding the Transportation Systems and accommodations in Broward County?
- Do you experience the required safety needed while driving, walking, biking, or using public transit in Broward County?
- Do you desire more convenient hours, stops, and faster service on Broward public transit (buses, community shuttles, rail, etc.)"?
- Do you feel that the County can do a better job in reducing traffic congestion and/or improving light synchronization?
- Which concerns shared in the session are most important to you? (Ranking)
- Other insights... (relevant to the focus group participants but not covered in the other inquiries.)



Participant Composition...

Invited Focus Group applicants represented all demographics in Broward County. Invitations to participate was extended by the MAP Broward Administration staff. The latter selected participants from the 700+ pool of eligible applicants. Respondents provided information on the following areas of interest...

- Age
- Ethnicity (African American, Hispanic, Caucasian, Asian, Native American, etc.)
- Gender (including non-binary)
- Preferred language
- Preferred Location
- Income brackets
- Employment Status (including retired, student, etc.)
- Method of transportation



Transportation Types Used by Participants...

The types of transportation used by participants was as diverse as the group members themselves. Transportation used included...


- Private Car
- Shared Ride Services/Drivers such as (Tops, Lyft, Uber, etc.)
- County Bus Transportation
- Express Bus Systems
- Commuter or Intercity Passenger Rail
- Community Shuttles
- Bicycle/Motorized Bikes
- Pedestrians (walking)

To warm-up each group and gauge their reasons for wanting to participate, facilitators asked: Why Did You Decide to Participate in our Focus Groups?

- ADA Advocacy
 - ADA Advocate noted that the County has "missed the mark."
- Shared Ride Services
 - The TOPS application is invasive, and documents are not electronically uploaded but mailed.
- Logistics Anxiety
 - Snowbirds shared that the existence of high anxiety in their attempts to be mobile in Broward.
- Safety Issues
 - Several participants noted that they enjoy walking and biking but take their lives in their own hands because of the hazards that exist from drivers in the area.
- Convenience
 - There are few stops that require long walks and schedules/routes are unreliable.
 - Public Transportation is not convenient. West Broward.
- Light Synchronization
 - County can do a better job in reducing traffic by tackling the traffic lights issues.
- Community Involvement
 - Want to impact enforcement of driver behavior (specifically speeding).
- Education
 - Wanted to learn more about the community.



Safety while driving, walking, biking, or using public transit...



- No one in the group felt safe driving, walking, or biking.
 - Participants did agree that residents can change their mindset on the bike system when polled. However, the pedestrian infrastructure is terrible.
- Even motor scooters are experiencing hazards due to defensive driving of motor vehicles of all sizes.
- Shelters are not safe because homeless people reside at these locations. Bus Stands (Poles) don't provide shelter from the natural elements.
- Poles designed to separate bikers/pedestrians, etc. are not enough to be protected from drivers of any kind.
 - One of the biggest fears is texting while driving.
- Sidewalks are absent in high traffic areas putting pedestrians and bikers in hazardous conditions.
- Current safety measures do not work.
 - Residents can change their mindset on the bike system.
 - The pedestrian infrastructure is terrible.



More convenient hours, stops, and faster service on public transit (buses, community shuttles, rail, etc.)"...

- Convenience of bus/shuttle stops do not exist.
- Reduce the size of the buses for some routes for better economics.
- Reduce the wait times.
- Long waits in Weston. Public transportation is discouraged.
- Graveyard shift workers are forgotten.
- The community is unclear on what "Enhanced Transit Options" means and user-friendly plan.
- A more seamless transportation footprint is needed. Where there is direct connectivity of each transportation service.
- Distance to nearest bus stop (e.g., 22- minute walk)
- "Public Transportation takes too long. (18 minutes by car, versus 2 hours via public transportation)"
- "The TOPS application is invasive, and documents are to be sent via traditional mail versus electronically uploaded; make electronic and expedite the process."
- "Community buses should be considered with routes that take residents to specific destinations as opposed to circular route"





Do you feel that the County can do a better job in reducing traffic congestion and/or improving light synchronization?

A sampling of insights are as follows:

- "Timing of the lights could be improved; I hate being stopped by a red light just after I got a green"
- "Half the problem with traffic congestion is distracted drivers, i.e., people who text while driving"
- "County could do a better job of reducing traffic by tackling the traffic light timing...the two issues are directly related"
- "The roads cannot accommodate the capacity of car drivers in Broward"
- "Light synchronization is a major cause of traffic congestion is some areas of Broward. Greater attention needs to be made in order to understand the root cause of it"

- Right on Red is a problem for pedestrians because people do not come to a full stop
- Is consideration of bi-directional lanes based on demand?
 - Floating bus lanes area a possibility with mid road stations that are ADA accessible.

Additional Insights...

- We do not have "complete" or fully planned communities that include a public transit grid
- It is a relief that Broward County is willing to listen to neighbors who walk, or bike and don't have the luxury of traditional transportation. The current paths are not considered safe.
- Accidents always seem to be Pedestrians and Bikers' fault and not the driver. Better accountability is needed.
- There are critical factors for quality of life that have been omitted when a "safe transportation plan" is considered or implemented. With heavier traffic, pathways to ease the flow must be in the conversation.
- Community buses should be considered with routes that actually take residents to destinations as opposed to circular routes
- Better safety measures. The enforcement of violators is insufficient
- Schedules should be accurate to create trust and encourage people to use public transit
- "Responsiveness of public officials is slow to non-existent to complaints and requests by citizens"
- Participants wanted to understand the project schedule.



Focus Group Participant Action Recommendations


Action Considerations were provided in the group members. Highlights are provided here.

- **Group Recommendation:** There should be curbs or visible poles that separate bikers and scooters on the road. Dedicated lanes are a must.
- **Group Recommendation:** Bus riders should be able to use credit/debit cards on the buses as opposed to having to go to another location to pay and then get on the vehicles.
- **Group Recommendation:** Sawgrass needs better evening and weekend service. If a bus in the evening is missed, the rider can be stranded.
- **Group Recommendation:** Light synchronization is a major cause of congestion in some areas. Great attention is needed to understanding the root cause.
- *Group recommendation:* Model the Hollywood Broad Walk and Las Olas systems along county streets where applicable
- *Group recommendation:* Enforcement of fines for violators
- **Group recommendation:** Sidewalks exclusive to pedestrians, bikes and certain scooters are needed and can ensure a higher level of safety.
- **Group Recommendation:** A more seamless transportation footprint is needed. Where there is direct connectivity of each transportation service. Additionally better shuttle services to the outer fringes and back is ideal.

Impacts of Advertising on Transit

 Advertising generates over half a billion dollars for Transit Agencies nationally (American Public Transportation Association - APTA) 	 Transit ads reach up to 83 % of commuters on weekdays and 69% on weekends (APTA)
 Generated close to \$9.5 million dollars for BCT over the past six years 	Promote local and small businesses in the community
 Revenue goes directly to improving the quality of public transportation 	 Efficient and effective way to make a significant, memorable impact.
 No empirical evidence that transit advertising has an adverse impact on ridership 	 Increase brand exposure, reach a wider audience, increase visibility frequency, and strategically meet consumers where they are located
 Advertising is a form of revenue that will remain in demand in the future 	 Increases the likelihood of out-of-home purchases, exposes new brands, and generates brand recall




BCT Advertising Program

- Procurement of new advertising vendor in progress.
- Contract term is for 3 years, with two one-year options.
- Vendor sells advertising on selected bus exteriors/interiors and terminals.
- New contract eliminates "full bus" wraps and adverting on the rear of the bus.
- Vendor provides minimum annual financial guarantee to BCT.
- Additional revenue to BCT based on agreed percentage of the value of Advertising sold above the minimum annual guarantee.

Advertising Approval Process

- Vendor representative submits proposed advertising to BCT for review, approval, or disapproval.
- BCT reviews proposed advertising in accordance with the County's "Advantage Marketing Plan" and provides feedback within 10 business days.
- BCT prohibits advertising space from being subdivided or resold by any parties other than the vendor without the express written consent of BCT.



Prohibited Advertisement Content


- Defamatory, libelous, slanderous, obscene, religious, or political
- Tobacco, alcohol, human reproduction/sexuality products or services
- Profanity, demeaning or disparaging words
- Firearms
- Violence, unlawful goods or services, and unlawful conduct
- Posing a potential danger, such as the words "stop," "danger," or other words likely to interfere or mislead pedestrians or traffic
- Failing to meet County standards as specified by the County's "Advantage Marketing Program"





BCT Transit Advertising Summary

- BCT's Transit Advertising Program provides a long-term revenue source that can be used to advance public transit service.
- The next advertising contract makes significant changes such as eliminating full bus wraps and provides a balance between the transit system's brand image and providing additional revenues.
- Advertising restricted on premium services to help brand those unique, specialized services.

The County Administrator is required to approve the New MPO Evaluation and Ranking Process (New MPO E&R Process) annually.



% Breakdown of CBEs by Race




