2. Motion to Consider and Approve Public Works Surtax Projects

The Public Works Department (Public Works) delivers surtax-funded roadway and bridge projects throughout the County. The Oversight Board reviewed the following Public Works projects, anticipated to be delivered as part of the Five-Year Plan (2021-2025) on August 14, 2020, but did not approve them as part of the FY2021 Budget action:

- **A.** Public Works project M101 (Copans Road and NW 42nd Avenue) was expected to enter its Construction phase in FY 2022 but is ahead of schedule. Construction costs are estimated at \$961,600 (which is consistent with the cost estimate included in the Five-Year Plan) and are included in a supplemental budget request Agenda Item being considered by the Board of County Commissioners May 4, 2021.
- **B.** Public Works project S10 (Copans Road from NW 42 Avenue to 36 Avenue) was expected to enter its Construction phase in FY2022 but is ahead of schedule. Construction costs are estimated at \$1,081,000 (which is consistent with the cost estimate included in the Five-Year Plan) and are included in a supplemental budget request Agenda Item being considered by the Board of County Commissioners May 4, 2021.
- **C.** Public Works project IO1 (Flamingo Road at New River Greenway) was expected to enter its Construction phase in FY2022 but is ahead of schedule. Construction costs are estimated at \$570,000 (which is consistent with the cost estimate included in the Five-Year Plan) and are included in a supplemental budget request Agenda Item being considered by the Board of County Commissioners May 4, 2021.
- **D.** Public Works project IO2 (Pine Island Road at Southgate) was expected to enter its Construction phase in FY2022 but is ahead of schedule. Construction costs are estimated at \$2,076,000 (which is consistent with the cost estimate included in the Five-Year Plan) and are included in a supplemental budget request Agenda Item being considered by the Board of County Commissioners May 4, 2021.
- **E.** Public Works project IO3 (NW 31st Avenue/Lyons Road at McNab) was expected to enter its Construction phase in FY2022 but is ahead of schedule. Construction costs are estimated at \$2,300,500 (which is consistent with the cost estimate included in the Five-Year Plan) and are included in a supplemental budget request Agenda Item being considered by the Board of County Commissioners May 4, 2021.
- F. Public Works project I04 (Rock Island at Royal Palm) was expected to enter its Construction phase in FY2022 but is ahead of schedule. Construction costs are estimated at \$2,050,500, an increase over original Five-Year Plan estimate of \$1,846,000 because of added scope (traffic study suggested need for dual left-turn lanes for north- and south-bound approaches, as well as righthand turn lanes east- and west-bound). Surtax funding for the project is included in a supplemental budget request Agenda Item being considered by the Board of County Commissioners May 4, 2021.
- **G.** Public Works project I14 (Griffin Road at Old Griffin Road) was expected to enter its Project Planning phase in FY2022 but FDOT is scheduled to begin Project Development and Environmental (PD&E) in July 2021. The surtax is contributing \$235,000 to FDOT's PD&E Study (down from \$360,600 originally estimated and included in the Five-Year Plan) per the supplemental budget request Agenda Item being considered by the Board of County Commissioners May 4, 2021.



Public Works is also requesting approval as to the eligibility of the following <u>new project</u> not previously evaluated by the Oversight Board and not currently contained in the Five-Year Plan (FY2021-2025):

H. Public Works Project O104 (Flamingo Road over Snake Creek Canal) was recently identified with structural deficiencies by FDOT. Designed in-house using gas taxes, the project is construction-ready and is estimated to cost \$3,300,000. Surtax funding for the project is included in a supplemental budget request Agenda Item being considered by the Board of County Commissioners May 4, 2021.
