Dear Mr. Eubanks:

In accordance with Section 163.3101, Florida Statutes (2019), the Broward County Evaluation and Appraisal Notification Letter is due on December 1, 2020 per the Department of Economic Opportunity's Evaluations and Appraisal Notification Schedule.

Broward County adopted a new land use element (BrowardNext) in April 2017 which addressed climate change, targeted redevelopment, multi-modal, natural resource protection and enhancement, affordable housing, disaster planning, and post-disaster redevelopment, and renewed intergovernmental partnership. In addition, the County adopted new versions of all remaining elements (BrowardNext 2.0) to address the same in March of 2019. BrowardNext and BrowardNext 2.0 engaged local governments and interested parties in an extensive public outreach effort to evaluate and update the various elements. Based on the all-encompassing nature and timing of the referenced updates, please consider this letter as notification that Broward County will not be processing an Evaluation and Appraisal Report.
