A meeting of the Broward County Planning Council, Broward County, Florida, was held in Room 422 of the Government Center, Fort Lauderdale, Florida, at 10:00 a.m., Thursday, April 22, 2021.

The meeting quorum and format were consistent with Section 1-233 of the Broward County Code of Ordinances regarding advisory boards utilizing communications media technology in the form of telephonic conferencing during a declared state or local emergency. To promote social distancing and avoid risk of additional community spread of the Coronavirus (COVID-19), this Public Hearing was not open to physical attendance by members of the public or the media. Members of the community were able to participate utilizing telephonic conferencing, as well as view the live meeting via webcast.

CALL TO ORDER

The Chair called the meeting to order.

PLEDGE OF ALLEGIANCE

Secretary Angelo Castillo led everyone in reciting the Pledge of Allegiance.

ROLL CALL

Following the Roll Call by the Real Time Reporter, the Chair declared a quorum present.

REAPPOINTMENT

The Chair acknowledged and congratulated the Council's reappointed member, Vice Mayor Beverly Williams, on behalf of Commissioner Dale V.C. Holness.

Following the Chair's request for a motion, a motion was made by Secretary Castillo and seconded by Mayor Gomez to approve the Consent Agenda. The Planning Council unanimously approved the Consent Agenda, Items C1 through C4.

REGULAR AGENDA

Prior to the start of the Regular Agenda, Ms. Boy noted the additional agenda materials that were received and sent to all Planning Council members regarding Items R 2 (email from the Broward County Office of the County Attorney) and PH 6 (correspondence from interested parties and PowerPoint presentation). The Council accepted the additional agenda material without objection.

R 1 FISCAL YEAR 2022 BUDGET PROPOSAL

Ms. Boy reported to the Board that the Fiscal Year 2022 budget proposal of \$1.267 million dollars is an increase of 4.5% over Fiscal Year 2021 due to increases in personal service line items and no changes to the operating budget. Ms. Boy also noted the lower revenue estimate was in part due to fee exemptions for land use plan amendments that are filed with at least a 15 percent set aside for affordable housing subject to a legally enforceable mechanism.



Following the Chair's request for a motion, a motion was made by Secretary Castillo and seconded by Mayor Gomez to recommend approval of the proposed budget and to forward the same to the County Commission. The motion was unanimously approved.

R 2 Local Planning Agency Review: Proposed Revisions to the Broward County Code of Ordinances, Chapter 27, Article V, Water Resource Management, Sections 27-192 and 27-200, Establishing a Future Conditions 100-Year Flood Elevation Map.

Ms. Boy reported that the proposed revisions are consistent with climate resiliency, water resource management and wellfield strategies and policies and staff recommends to transmit the same to the Broward County Board of County Commissioners.

Mr. Carlos Adorisio from the Broward County Environmental Engineering and Permitting Division gave an overview of the proposed revision and noted that the establishment of the map will set the development standard for future planning and regulatory purposes.

The Council engaged in a brief discussion and questions.

Following the Chair's request for a motion, a motion was made by Secretary Castillo and seconded by Mayor Hardin to find the proposed revisions consistent with the policies of the Broward County Land Use Plan and transmit same to the Board of County Commissioners. The motion was unanimously approved.

The Chair also directed Planning Council staff to invite the County's Environmental staff to a future meeting to make a presentation regarding sea level rise, drainage and flooding policies and issues.

Ms. Boy suggested that the Council could consider cancelling the May meeting and moving those items to the June 24, 2021, meeting date, as It would result in having more consistency in the meeting schedule, as the July meeting had previously been cancelled. Without objection, the Council cancelled the May meeting date.

Ms. Boy noted that she will send a survey to the Council Members regarding the Member's preference for the receipt of agenda materials.
