PH 1 AMENDMENT PCT 19-2

Second Public Hearing on Text Amendment to the Broward County Land Use Plan regarding residential uses in the "Commerce" land use category – Recommended approval per Planning Council staff recommendation, including additional language regarding local land development regulations to address distance and separation requirements.

PH 2 AMENDMENT PC 19-6

Public Hearing on Small Scale Amendment to the Broward County Land Use Plan – City of Lighthouse Point – *Recommended approval per Planning Council staff recommendation, recognizing the applicant's confirmation to comply with all necessary Environmental Resource License requirements and develop a hurricane evacuation and reentry plan in coordination with the City including not requiring a second Planning Council public hearing.
