Commissioner Rich stated that Broward County will provide \$5,000,000 for three project applications in the cities of Fort Lauderdale, Pompano, and Pembroke Pines. In light of House Bill 7103, the County is also requesting that the State of Florida consider affordable housing as infrastructure or a capital facility to potentially allow for residential and/or non-residential linkage fees.

Commissioner Rich requested the for the item to be placed on the agenda for further discussion. Ms. Boy advised that the item could be placed on the December regular agenda and consideration would be as early as February due to January's Planning Council meeting is set exclusively for the land use plan amendment PC 20-2 Tamarac/Woodlands.
