Dr. Jurado gave a presentation on Planning for Sea Level Rise and Resilience in Broward County. Dr. Jurado discussed the community's resilience challenges which include rising sea level, rainfall, and storm surge; increase in flood severity, impacts and disruptions; infrastructure damage and safety concerns; economic exposure implications; and quality of life considerations. Dr. Jurado described the risks and economic consequences.

At the conclusion of the presentation, Dr. Jurado responded to Council member's questions.

The Chair thanked Dr. Jurado for her presentation and reported the SEAHIVE project in Pompano Beach will be completed by the middle of September 2023. Chair DiGiorgio thanked Dr. Jurado for her support with the project.
