## **Wastewater Discharge Permit Transfer Form**

By completing and submitting this form, the New Owner is requesting transfer of a Broward County Water and Wastewater Services (BCWWS) Wastewater Discharge Permit from one business entity to another. In accordance with the Broward County Sewer Use Ordinance section 34-142(b) (3). A wastewater discharge permit may be transferred to another person only if the permittee gives at least thirty (30) days advance written notice to the director and the director approves the wastewater discharge permit transfer. BCWWS must receive this form signed and completed by an authorized representative of the New Owner prior to the date of ownership transfer.

An authorized representative is defined as follows:

- a. The president, secretary, treasurer, or a vice-president of the corporation in charge of a principal business function, or any other person who performs similar policy or decision-making functions for the corporation;
- The manager of one or more manufacturing, production, or operation facilities employing more than two hundred fifty (250) persons or having gross annual sales or expenditures exceeding \$25 million (in second-quarter 1980 dollars), if authority to sign documents has been assigned or delegated to the manager in accordance with corporate procedures;
- c. An authorized partner or proprietor if the industrial user is a partnership or sole proprietorship, respectively; or
- d. A director or highest official appointed or designated to oversee the operation and performance of the activities of a government facility, or their designee, if the industrial user is a federal, state or local governmental facility.
